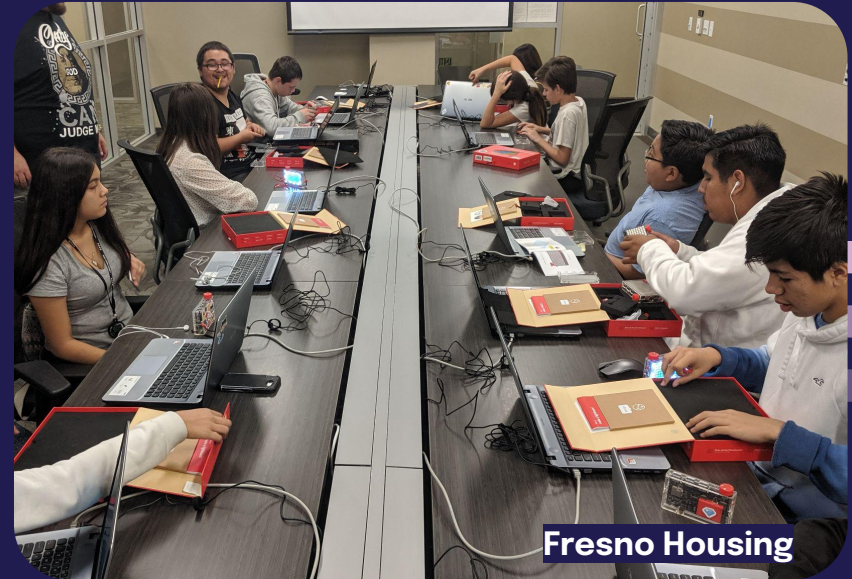

The activities necessary to ensure that all individuals have access to:

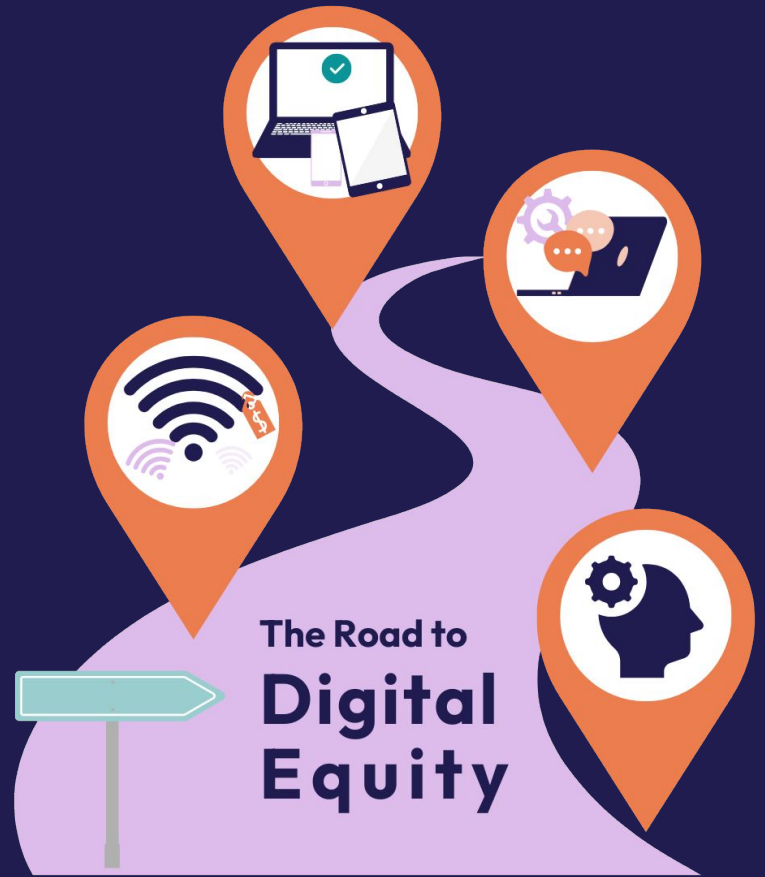
- Affordable home broadband

- Online content designed to enable self-sufficiency



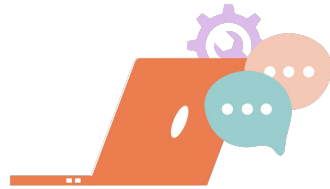

Solution: Affordable & Low Cost Broadband

What is Broadband?

Broadband is the transmission of wide bandwidth data over a high speed internet connection

In March 2024, the Federal Communications Commission (FCC) defines the minimum standard for broadband speed as 100/20

- 100 megabits per second for downloading
- 20 megabits per second for uploading



Broadband Adoption

Broadband adoption is daily access to the internet:

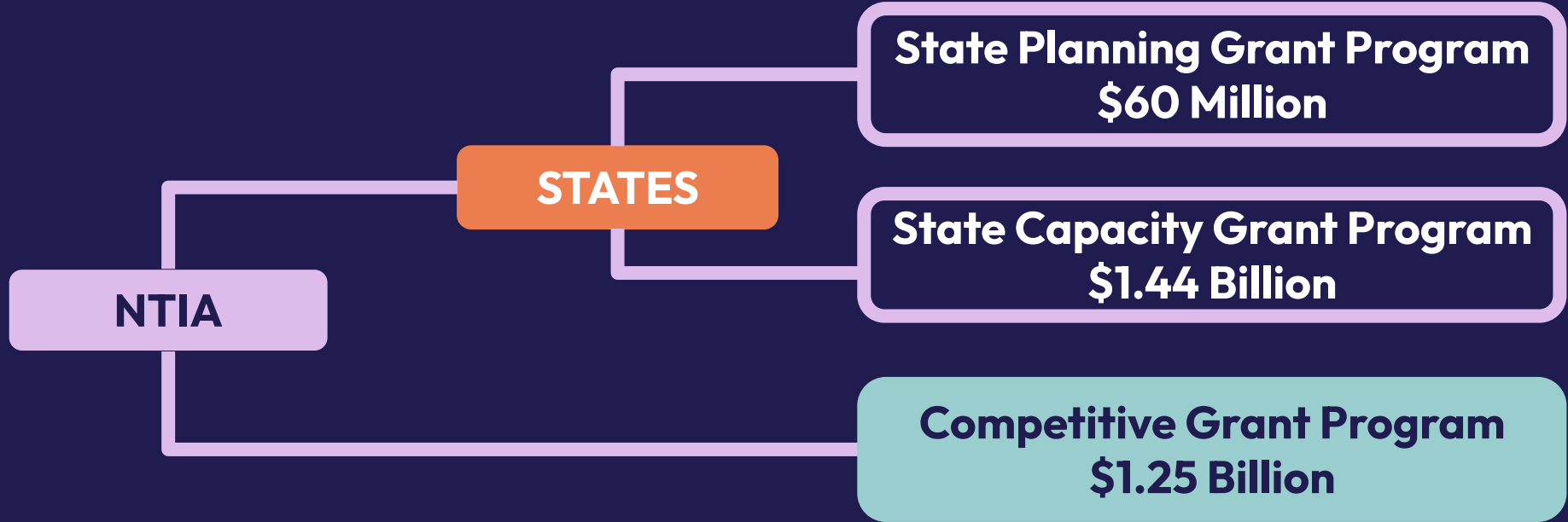
- At speeds, quality and capacity necessary to accomplish common tasks,
- With the digital skills necessary to participate online, and
- On a personal device and secure, convenient network

State Digital Equity Capacity Grant

The National Telecommunications and Information Administration (NTIA) opened the State Capacity Grant on March 29, 2024

- \$840 million in grant funding available to states, US territories, and Native entities
- The funds will be used to implement digital equity plans



Putting DE Plans Into Action

To help the success of these plans, states and territories must consider various factors such as:

- Focusing on covered populations
- Implementing measurable strategies
- Encouraging long-lasting and meaningful change
- Engaging stakeholders



State Subawards

States and Territories *May* Award Subgrants to Implement the State's Digital Equity Plan

- Supporting the implementation of the plan
- Digital inclusion activities that align with the plan
- Reporting the entities' digital inclusion activities to the State



Native Entities Capacity Grant

Applications

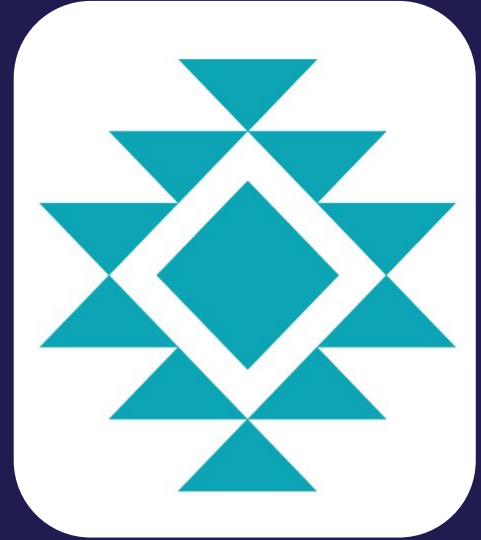
- Applications were open September 25, 2024 and are due February 7, 2025
- \$45.3 million is available for Native Entities
- Grant awards will range from \$500,000 to \$2,000,000
- The grants are competitive



Native Entities Capacity Grant

Awards

- NTIA expects to begin making awards to Native entities in the Summer of 2025
 - Funds may be issued on a rolling basis
- Entities that receive funding must complete the grant within 5 years

Digital Equity Competitive Grant

Competitive Grants

- Applications for States and Native Entities were due to NTIA by September 23, 2024
- \$1 billion allocated funds in 1st Tranche (\$250M in future NOFO)
- 65 projects recommended for award in Jan 2025



Use Of Grant Funds

Projects Will

- Address gaps in the implementation of State Digital Equity Plans, and/or
- Supplement or further advance State Digital Equity Plans, and/or
- Address barriers to digital equity that State Digital Equity Plans failed to identify



Current Status of DEA Grants

State Digital Equity Capacity Grant: \$1.44B

- **States: \$760.8 M**
- **Territories: \$8.4M**
- **Tribal Entities: \$45.3M**
- **Future NOFOs: \$600M**

What's at Risk for the Capacity Grant:

- **State & Territory Grants**
 - Those without a signed contract
 - Pauses or changes to approved/active work
 - Veto to projects and subgrant submissions
- **Native Entity grants**
 - Not yet evaluated
 - Potential loss \$45.3M
- **\$600 Million expected in future NOFOs for:**
 - State, Territory, and Native Entities

Current Status of DEA Grants

Digital Equity Competitive Grant: \$1.25B

- **\$1B Allocated in NOFO 1**
- **65 projects Recommended for award totaling \$619M**
- **4 projects with signed contracts**
- **Future NOFO with ~\$250M**

What's at Risk for the Competitive Grant:

- The entire program - \$1.25B
 - \$681M - 65 projects recommended for award & 4 signed contracts could be rescinded, redirected, or reallocated
 - \$381M - unallocated funds from this NOFO
 - \$250M - future NOFO

Digital Discrimination

FCC has finalized rules for preventing and eliminating digital discrimination.

What the rules cover: “any aspect of broadband internet access service that impedes, impairs or denies ‘equal access’ to that service.”

- Exa: Discrimination in broadband pricing, customer service, infrastructure upgrades
- Rules protect consumers even if there was no intent
- Individuals and communities will be able to file complaints with FCC

Broadband Labels

The Broadband Consumer Labels include information on:

- Pricing
- Introductory rates
- Data allowances
- Performance metrics
